

Swimmers Agreement

I,	a r	egistered member of
	Swimmin	g club, hereby agree
to become a member of the Auckland Swimming Association team travelling and competing		
at	from	to
inclusive, under the following terms and conditions, whilst a member of such team.		

I UNDERTAKE:

- 1. To travel to and depart from the place of assembly of the team upon the dates and by means of conveyance decided upon by the Auckland Swimming Association, NZSF.
- 2. To co-operate and remain under the management and direction of the Team Manager or person appointed by him/her in all respects from the date of assembly until my return, and to comply with all request made by him/her during this period.
- 3. I hereby agree upon assembly, to supply to the team manager a certificate from a medical practitioner, as to any drugs or medication I have prescribed.
- 4. In the event of my suffering injury which might affect my performance prior to the assembly of the team. I undertake to advise the Auckland Swimming Association.
- 5. After assembly of the team I undertake to disclose immediately to the Team Manager, any injury or condition which might prejudice my ability to compete to that standard which first gained me selection for the team.
- 6. I undertake to conduct myself in a proper manner, and to exercise by best endeavours to render myself fit to ensure maximum performance in competition, and I agree to return to Auckland forthwith if at any time ordered to do so by the Manger.
- 7. That during the period mentioned in paragraph (2) above, and for a further period of one month after my return to Auckland, I will not, except with the approval of the Team Manager and in the presence of my Team Manager, supply any swimming or team information or photographs to the press, radio or television, or for the purpose of use in the press, radio or television, either in writing or by word of mouth, and that I will not, without the consent and approval of the Team Manager, permit the use of any remarks made by me.
- 8. That I will not possess, consume, administer, purchase or dispose of by any means any narcotic drugs of any kind. I further agree that I will not consume or administer any alcoholic liquor except with the consent of the Team Manager, but such consent shall not be given or deemed to be given in respect of any time, place or condition which is contrary to law.

- 9. That I will wear on all occasions as shall be directed by the Team Management, such items or apparel as shall be prescribed by the ASA including swimwear, casual wear and official uniform.
- 10. That I will be entirely responsible for the carriage and transportation of any and all personal of effects given to or purchased by me prior to and during the period of this agreement, and I further agree to meet any charges involved in the event of my baggage being in excess of that allowed by the Team Management.
- 11. I declare that I have not been guilty of any act or omission whereby I have become liable to be declared ineligible to compete in amateur swimming competition.
- 12. I authorise any Medical Practitioner who may examine or treat me, while on the ASA trip and under jurisdiction of a Team Manager, to make full disclosure to the Team Manager of any diagnosis or treatment, that has been made or prescribed for me.
- 13. I acknowledge that the Auckland Swimming Association, NZSF has expressly provided that in the event of any breach of discipline or misbehaviour of my part, I am liable to the following penalties:
 - A to be sent home forthwith
 - B to be deprived of any privileges or allowances
 - C to be the subject of a report to the ASA
 - D to be immediately suspended from current competition

and I accept membership of an Auckland Team under these express conditions.
