## **R1 INTERPRETATION**

R1.1 In these Regulations, except where a contrary intention appears,.

"Association" means the Auckland Swimming Association.

"Championships" means the Auckland Swimming Championships.

"Competitive Swimming Group" means that panel set by the authority of Rule 7.04 of the rules of the Auckland Swimming Association for the government of competitions in the Auckland Swimming Association Region.

"F.I.N.A." means the Federation Internationale de Natation Amateur.

Events Management Group means that panel set by the authority of Rule 7.05 of the rules of the Auckland Swimming Association for the government of League competitions in the Auckland Swimming Association Region.

Male shall import the female.

"S.N.Z." means Swimming New Zealand.

"Rule" means the Rules of the Auckland Swimming Association Inc.

Singular shall import the plural.

## **R.2 AUCKLAND SWIMMING CHAMPIONSHIPS**

### **R2.1 AUTHORITY**

R2.1.1 In accordance with Rule 14 of the Association, the Association may hold annually Auckland Swimming Championships.

R2.1.2 No Club shall employ or permit to be employed the term "Championship" in respect to any race other than a Club Championship, without the approval of the Association, nor without the prior approval of the Association shall any description be applied to any device or advertisement employed that will or may convey the impression that any event is a Championship event carrying the title reserved by these rules to events held under the rules of SNZ Inc.

### **R2.2 COMPETITIONS**

R2.2.1 The Championships may consist of seven separate meetings. Any or all of these meetings may be combined at the discretion of the Competitive Swimming Group. They shall be:

a1) The Age Group Individual Championship events for age 9/u, 10, 11, 12 or as the Competitive Swimming Group may decide from time to time

a2) The Open and Age Group Individual Championship events for age 13, 14, 15, 16-18 yrs and Open or as the Competitive Swimming Group may decide from time to time.

- b) The Open and Age Group Relay Championship events.
- c) The Open Water Long Distance Championships.
- d) The Winter Championships.
- e) The Open Short Course Spring Championships
- f) The Open Short Course Autumn Championships

R2.2.2 All meetings of the Championships will be conducted under the rules of the Swimming New Zealand Inc. except that these regulations will also apply.

R2.2.3 The Competitive Swimming Group or the Organising Committee may make such local rules as it sees fit, not being inconsistent with these Regulations. Such Local rules must be reproduced in full on the Poster advertising the Meet.

## **R2.3 ASA BOARD - POWERS**

R2.3.1 The Administration Board may, within the terms of Rule 14.01.2, and at its discretion, authorise any club within the Association Region to hold on behalf of the Association all or any of the meetings that form the Championships

R.2.3.2 Where any Club is authorised to hold a meeting of the Championships under the terms of R2.3.1 the ASA Board reserves full power over such meeting. In the event of any Club, to which the conduct of a meeting of the Championships is allocated, failing to carry out the meeting, or in the opinion of the ASA Board failing to take such steps necessary to put in place the allocated meeting, the ASA Board shall have power to take over the organisation of that meeting and appoint an Organising Committee or request any other Club to organise the meeting.

## **R2.4 CONTROL OF MEET**

R2.4.1 Each meeting of the Championships shall be managed by an Organising Committee. The Organising Committee Chair shall be appointed by either Events Management Group, or where a meeting has been allocated to a club, the Organising Committee Chair shall be appointed by that club.

R2.4.2 The Organising Committee Chair shall have control of all administrative matters in respect to the meeting of the Auckland Championships for which he is appointed. Where matters in respect to the meet, which are not covered in these regulations or elsewhere, must be decided, he shall consult with the Competitive Swimming Group for a decision. Where matters of a technical nature arise, which are not covered in these regulations or elsewhere, he shall consult with the Meet Director appointed under regulation R2.5.1 for a decision. Such decision shall be final.

R2.4.3 The Organising Committee Chair may appoint, with the approval of the Events Management Group, or when the meeting is vested in a club, with the approval of that club, such administrative assistants to deputise for him as he deems necessary. Those assistants will bear the title of Organising Committee Member and have such delegated responsibility and authority as the Organising Committee Chair delegates either generally or in particular.

## **R2.5 TECHNICAL**

R2.5.1 The Auckland Technical/Technology Group shall appoint a New Zealand qualified Referee, to be the Meet Director for each or all meetings forming the Championships. Such appointment shall be made at least two months prior to the date set for the closing of entries for the first session of the first meet of the Championships. That appointment shall be communicated to the ASA Board.

- R2.5.2 The Meet Director will chair the Jury of Appeal or in his absence, or when he is the session referee, appoint a person qualified as an Auckland Referee or better, who is not a referee or judge of stroke for that session, as chairman for any Jury of Appeal convened during that Session.
- R2.5.3 The chairman of the Jury of Appeal shall appoint two other suitably qualified persons who are not involved in the matter to that jury to hear any protest or appeal on any matter regarding the meet.
- R2.5.4 The Association Technical / Technology Group shall appoint all technical officials at all sessions of all meetings of the Championships.
- R2.5.5 Those appointments may be made from suitably qualified Technical Officials from both within the Association or from other Regional Associations or Centres.
- R2.5.6 At Championship meetings, the Meet Director shall have the power to suspend or expel from the meeting any competitor or other person. The Right of Appeal under Rule SRG13 shall apply.
- R2.6 ENTRIES**
- R2.6.1 Competitors shall send their entries for the Championships, together with the entry fee, to the Secretary or some other responsible person of their club. The person who receives such entries shall, subject to the provisions of Regulation R2.6.5 of these regulations, forward them to the Organising Committee of the meet at the place and by the time specified in the Poster advertising the competition. Scratching from a race shall not relieve a competitor from the liability of paying his entry fee and no refund is claimable.
- R2.6.2 Visitors, as defined by Regulation R2.11.2, shall forward their entries as decided by the Organising Committee.
- R2.6.3 Late entries may be accepted by the Organising Committee for any event in the Championships prior to the commencement of Session 1, subject to the following provisions:
- (a) The entrant shall be charged the normal entry fee plus a penalty.
  - (b) No swimmer may enter as a late entry in an event being swum as a straight final.
  - (c) Late entries will not be accepted after a time that is to be determined by the Meet Controller in consultation with the Events Management Group
  - (d) Late entries will not be accepted where by acceptance of that entry it would necessitate a redraw of lane allocations for the competitors in that event.
  - (e) Following the commencement of Session 1, any late entries to be referred to the Meet Director.
- R2.6.4 The fee for entry to events, and the late entry penalty fee for the Championships shall be determined by the ASA Board  
Titleholders of individual Open grade events shall be accorded free entry to defend that title.



In addition, for the Auckland Summer Championships, there will be a 10 cents levy per entry, payable to the NZ Swimming Trust Inc.

R2.6.5 All entries for the Championships shall be made on the forms designated from time to time by the Events Management Group. The competitors club shall check and verify by authorised signature the seedtime submitted by the competitor. All seed times submitted must be either long course times or short course times converted to long course using the NATIONAL CONVERSION CONSTANTS.

R2.6.6 Club Representation - Refer to Rule 6.0 (Individual Membership).

R2.6.7 Scratching from a race shall not entitle a competitor to a refund of an entrance fee.

## **R2.7 QUALIFYING TIMES**

R2.7.1 Qualifying times may be applied to any event of the Championships by the Competitive Swim Group and the qualifying period where applicable shall be from 1 January in the preceding year or as from time to time decided by the Competitive Swim Group:

- (a) For Championships which are limited to Top 8, Top 16 or Top 24 etc, the qualifying performance time registered during the published qualifying period, shall be submitted with entries for seeding.
- (b) For other Championships -  
where the end of the qualifying period corresponds with the date for entry closure, then the swimmer's seed time shall be that of the qualifying performance registered during the qualifying period. Entries which do not comply with this requirement shall be disallowed.
- (c) For other Championships -  
Where the end of the qualifying period coincides with the actual event being swum, the times submitted for seeding shall be either -  
A time no faster than the swimmer's personal best; or  
NT (no time), which shall be considered the slowest time for seeding purposes.

Where a swimmer fails to register a qualifying time in a championship event and cannot supply proof that a qualifying time was registered during the qualifying period, their club shall be penalised by a fine as decided and published, from time to time, by the ASA Board

R2.7.2 Where a competitor has no qualifying time for an event of over 400 metres requiring such time that competitor may use a time for a shorter event of the same stroke. In the event that this occurs, that time shall be submitted to the Association Selector who shall indicate a probable time for that competitor for the distance. If that probable time is within the qualifying time for the event, the entry shall be allowed, otherwise the entry will be disallowed. The decision of the Association Selector shall be final.

- R2.7.3 Where any entry is disallowed under R2.7.1 or R2.7.2 the Club shall be advised by the Organising Committee Chair as soon as that decision is taken. In the event of any dispute arising from a swimmer being disallowed entry, the matter will be heard by a special Jury convened by the Chair of the Technical / Technology Group or a person holding similar qualifications and appointed for that purpose by him. The special Jury is to include the Chair of the Competitive Swimming Group and one other person. The decision of the Jury will be final.
- R2.8 ADVANCING TO FINALS**
- R2.8.1 The provisions of SNZ Rule SW3.2 with reference to advancing to finals and excepting the first paragraph, shall apply where applicable and with the necessary modification, to the Open events, age group individual events and relay events forming part of the Auckland Championships.
- R2.8.2 The provisions of SNZ Rule SW3.2.3 in relation to a dead heat result shall apply.
- R2.9 PROFITS AND LOSSES**
- R2.9.1 All profits from meetings forming part of the Championships shall become part of the general operating funds of the Association.
- R2.9.2 Where a club conducts an individual meeting of the Championships as defined in R2.2 that club shall retain all profits and carry any losses from that meeting.
- R2.10 WITHDRAWALS**
- R2.10.1 Withdrawals are required only for finals. Swimmers will be deemed to have withdrawn if they do not report to the Marshall at the appropriate time prior to their heat.
- R2.10.2 A swimmer who does not withdraw from their final will be liable to a fine of \$15.00. Finalists are deemed to include the first two reserves.
- R2.10.3 Withdrawals must be in to control within 15 minutes of the end of the session.
- R2.10.4 The Meet Director shall determine the acceptability on all matters where medical reasons or hardships are claimed.
- R2.11 VISITORS**
- R2.11.1 Visitors may compete in any meeting of the Auckland Championships in accordance with Rule 14.02.1.
- R2.11.2 A visitor is any competitor being a member of a swimming club affiliated to SNZ Inc., or affiliated to a member of F.I.N.A. and who is not a member of a club within the Association. Members of Masters and Water Polo Clubs are specifically excluded.
- R2.11.3 Where visitors are not eligible to hold an Auckland title or to Championship medals they may receive such awards as the Events Management Group shall decide from time to time.
- Visitors are not eligible to hold an Auckland title in age group events as listed in R2.2.1(a) Open and Age Group Championships or R2.2.1(d) Winter Championships, but may do so in all Auckland Open Championship events, including the Spring and Autumn Short Course Champs.

## **R2.12 MEDALS AND AWARDS**

R2.12.1 The prize for first, second and third place in any event of the Auckland Championships shall be a medal of a design and metal approved by the ASA Board.

R2.12.2 The Organising Committee may, subject to the prior approval of the Events Management Group, make other awards for finalists or other competitors.

<sup>1</sup>R2.12.3 In the Auckland Winter Championships, if a race record is set in both the heats and final, the fastest time only is eligible for points.

## **R2.13 AGE DATE**

The age date for the Auckland Championships shall be as at the first session of each meeting as defined in R2.2.1.

## **R2.14 SEEDINGS**

R2.14.1 (a) where heats are held as a combination of all grades, but finals are held in separate grades, seeding shall be graded into heats by times, slowest heat held first.

(b) where heats are held in separate age-grades seeding shall be as for FINA RULE SW3 except only the fastest two heats will be circle seeded.

R2.14.2 In events of 400 metres or of a greater distance no finals will be held and places shall be awarded on time basis, subject to the order of finish in each heat as decided by the judges or Electronic Timing and Judging Equipment where used. The competitors will be grouped in heats according to the fastest submitted times. The first heat will be filled with the fastest group, second heat with the next fastest succeeding group and each following heat with the next fastest group until completed. The order of holding the heats shall be on the basis of the slowest heat first and the fastest heat last.

## **R2.15 RELAY EVENTS**

R2.15.1 The members of a Relay team and their order of competing shall be nominated to the Chief Recorder\* prior to the commencement of the session in which the race shall be swum. A relay team member may compete in the race once only.

R2.15.2 The composition of a relay team may be altered between heats and finals of an event, provided that no team may make more than two changes and that the entire team including potential substitutes has been properly notified to the Chief Recorder prior to the commencement of the session in which the heats will be swum.

R2.15.3 Where a team is disqualified in a heat of an event, no member of that team or its substitutes may compete in the final of that event.

R2.15.4 Relay teams comprising members from more than one Club may be entered providing that those Clubs do not individually have sufficient members present to constitute a relay team.

R2.15.5 Composite relay teams shall be seeded in the normal way.

- R2.15.6 The number of composite relay teams competing in a final shall be limited to two in an eight-lane pool and one team in a pool of less than eight lanes.
- R2.15.7 Composite relay teams shall not not be eligible for first, second or third place awards, nor shall they be granted records.
- R2.15.8 All named swimmers in a team that actually compete in either the heat and or the final shall be eligible for medals.
- R2.15.9 Swimmers may swim up to the limit of the grade compared with the swimmers age where the age groupings are shown as Under a particular age. If the age grades are shown as specific age's then only swimmers of that age grade are eligible to compete.
- R2.15.10 Notwithstanding the foregoing, the meet may have special relays with Local Rules authorised and publicised under R2.2.3 of these Regulations applicable which may be at variance to these rules.

## **R2.16 OPEN WATER EVENTS**

- R2.16.1 The open water Long Distance events of the Auckland championships will be held over a measured course of 5 kilometres. Wherever practicable the course shall be triangular one of 1500 metres. Where an individual leg of the course exceeds 400 metres intermediate markers shall be placed. Within the triangle suitable boats shall circulate in such numbers that at no time during the race is any competitor more than 100 metres from a boat.
- R2.16.2 Open water, for the purpose of this Regulation shall include harbour, estuary, river and lake waters, save that it shall not be lawful to conduct the events under conditions whereby owing to the run of the tide or current from other causes the actual distance swum is a matter of conjecture.
- R2.16.3 Men and women shall swim simultaneously in one race, but shall be judged separately. The first man to finish shall be awarded the title of men's long distance champion and the first woman to finish shall be awarded the title of women's long distance champion.
- R2.16.4 Competitors for Open Water Long Distance Events shall before starting provide to the Controller of the meet a medical certificate of fitness from a Registered Medical Practitioner given between the closing of entries and the time of the race.
- R2.16.5 Other Open Water races may be organised and run in conjunction with the Championship Long Distance event at the discretion of the Competitive Swimming Group.

## **R2.17 SAVINGS**

Any matter for which the foregoing conditions do not provide shall be determined as the ASA Board may decide. Where a matter calling for an immediate decision arises during the course of a Championship Meeting, it shall be referred to the Jury of Appeal. The decision of the Jury of Appeal shall be final.

## **R2.18 PROGRAMS**

R2.18.1 The program of events and order of events for the Open and Age Group Individual Championship Meeting will be decided and published by the Competitive Swimming Group by the 31st day of May of the year preceding.

R2.18.2 The program of events for the Open and Age Group Relay Meeting shall be as follows:

## **R3 ASSOCIATION COMPETITIONS**

### **R3.1 AUTHORITY**

R3.1.1 The Association may from time to time organise competitions within and by authority of Rule 2.0.

### **R3.2 MEETING RULES**

R3.2.1 All meetings shall be held under the rules of Swimming New Zealand Inc. except that these Regulations shall apply and the programme shall state such.

R3.2.2 The provisions of Regulation R2.2.3 shall apply.

### **R3.3 CONTROL OF MEET**

R3.3.1 The meeting shall be managed by an Organising Committee\* who shall be appointed by the Events Management Group.

R3.3.2 The provisions of Regulation R2.4.2 shall apply.

R3.3.3 The Organising Committee Chair may appoint, with the approval of the Events Management Group, such administrative assistants to deputise for him as he deems necessary. Those assistants will bear the title of Organising Committee Member and have such delegated responsibility and authority as the Organising Committee Chair delegates either generally or in particular.

R3.3.4 The Organising Committee Chair shall prepare a financial budget for the meet and present it prior to any expenditure being undertaken. That budget shall be presented to the ASA Board for approval.

R3.3.5 All expenditure shall be approved by the ASA Board either generally for the meet or for particular items and that committee may put in place such controls as it sees fit.

### **R3.4 TECHNICAL**

R3.4.1 The Events Management Group shall advise the Auckland Technical / Technology Group details of date, place and the name of the Organising Committee Chair of any meeting that is being organised on behalf of the Association.

R3.4.2 The provisions of Regulations R2.5 in its entirety shall apply.

### **R3.5 ENTRIES**

R3.5.1 The provisions of Regulation R2.6 in its entirety shall apply.

### **R3.6 QUALIFYING TIMES**

R3.6.1 The provisions of Regulation R2.7 in its entirety shall apply.

### **R3.7 FINALS**

R3.7.1 The provisions of Regulation R2.8 in its entirety shall apply.

### **R3.8 WITHDRAWALS**

R3.8.1 The provisions of Regulation R2.10 in its entirety shall apply.

### **R3.9 VISITORS**

R3.9.1 The Competitive Swimming Group may regulate the entry of visitors to a meeting.

R3.9.2 A visitor is as defined in Regulation R2.11.2.

### **R3.10 AGE DATE**

R3.10.1 The age date for the meet shall be as determined for each meet by the Competitive Swimming Group

### **R3.11 SEEDINGS**

R3.11.1 The seeding of events shall be in accordance with F.I.N.A. rule SW3 or as determined for each meeting by the Competitive Swimming Group

### **R3.12 RELAY EVENTS**

R3.12.1 The provisions of Regulation R2.15 in its entirety shall apply.

### **R3.13 PRIZES**

R3.13.1 Prizes for competition for meetings run on behalf of the Association shall be approved by the Events Management Group and published on the notice calling for entries.

### **R3.14 SAVINGS**

R3.14.1 Any matter for which the foregoing conditions do not provide shall be determined as the ASA Board may decide. Where a matter calling for an immediate decision arises during the course of a Meeting, it shall be referred to the Jury of Appeal. The decision of the Jury of Appeal shall be final.

## **R4 INTERCLUB COMPETITIONS**

### **R4.1 AUTHORITY**

R4.1.1 All interclub races and competition organised or conducted by member Clubs of the Association shall be under the control of the Association.

- R4.1.2 The Association shall delegate to the Events Management Group the authority to regulate the holding of all interclub competition within the boundaries of the Association.
- R4.1.3 Clubs wishing to conduct interclub competition shall make application to the Events Management Group advising the date they wish to hold the event and programme of events.
- R4.1.4 The Events Management Group will consider all applications for interclub competitions and authorise or otherwise the holding of such competitions
- R4.1.5 When authorising the holding of a meeting, the Events Management Group may impose such conditions as it shall determine.
- R4.1.6 **TWO WAY MEETS**
- (a) A Club may decide to hold a two way invitational meet with one other Club only and as such may determine to run such a meet outside the provisions of this Regulation.
  - (b) In the event of a performance being achieved that would qualify for a claim on a record the provisions of R7.4.1 shall apply.
  - (c) In the event of a performance being achieved that would be used as a qualifying time for entry into other meets the Referee must be a qualified Referee and as such sign the completed programme indicating that he was satisfied with the level of competence of all officials involved.
- R4.2 RULES OF MEET**
- R4.2.1 All meetings shall be held under the rules of Swimming New Zealand and the programme shall state such.
- R4.2.2 Meetings may have local rules applied, as long as such local rules are not at variance with these rules or the rules of Swimming New Zealand. Such Local Rules must be reproduced in full on the poster advertising the Meet.
- R4.3 ENTRIES**
- R4.3.1 All entries for interclub meetings shall be made on the form approved by the Events Management Group or on disk accompanied by printout.
- R4.3.2 Where the entry form used is not one purchased from the Association, or is a multiple entry form, the organising body shall pay to the Auckland Association a levy of 60 cents per entry.
- R4.4 RIGHT OF ENTRY**
- R4.4.1 The Board of the Association, Publicity Officer, and Selectors shall have right of free and unencumbered access to any meeting in the Association area held under the rules of SNZ Inc.
- R4.4.2 A Life Member of the Association shall have right of entry free of charge to all meetings being held in the Association area under the rules of SNZ Inc.

**R4.5 CONTROL**

R4.5.1 All meetings shall be managed by an Organising Committee Chair who shall be appointed by the organising Club. Such appointment shall be communicated to the Events Management Group.

R4.5.2 The Organising Committee Chair shall have control of all administrative matters as delegated by the organising Club in respect to the meeting for which he is appointed. Where matters of a technical nature arise, which are not covered in these regulations or elsewhere, he shall consult with the Auckland Technical/Technology Group for a decision. Such decision shall be final.

R4.5.3 The Organising Committee Chair may appoint, with the approval of the organising Club, such administrative assistants to deputise for him as he deems necessary. Those assistants will bear the title of Organising Committee Member and have such delegated responsibility and authority as the Organising Committee Chair delegates either generally or in particular.

**R4.6 TECHNICAL**

R4.6.1 The Events Management Group shall advise the Auckland Technical/Technology Group details of date, place and the name of the Organising Committee Chair of any such meeting.

R4.6.2 The Auckland Technical/Technology Group may appoint a qualified Auckland Referee or better, to be the Meet Director for the meeting. Such appointment shall be made at least one month prior to the date set for the closing of entries for the first session of the meet. That appointment shall be communicated to the Organising Committee Chair appointed under the terms of Regulation R4.5.1 and to the Competitive Swimming Group.

R4.6.3 The Meet Director will chair the Jury of Appeal or in his absence, or when he is the session referee, appoint a person qualified as an Auckland Referee or better, who is not a referee or judge of stroke for that session, as chairman for any Jury of Appeal convened during that Session.

R4.6.4 The Chairman of the Jury of Appeal shall appoint two other suitably qualified persons who are not involved in the matter to hear any protest or appeal on any matter regarding the meet.

**R4.7 QUALIFYING TIMES**

R4.7.1 Qualifying times may be applied to any event of the meeting by the organising Club. Where qualifying times have been applied they shall be enforced by disallowing any entry not so qualifying. The qualifying period where applicable shall be as determined by the organising Club.

R4.7.2 The provisions of Regulation R2.7.2 shall apply.

R4.7.3 Where any entry is disallowed under R4.7.1 or R4.7.2 the Club shall be advised by the Organising Committee Chair as soon as that decision is taken. In the event of any dispute arising from a swimmer being disallowed entry, the matter will be heard by a special Jury convened by the Chairman of the Technical/Technology Group or a member of that committee acting with delegated authority, whose decision will be final.



#### **R4.8 REFUNDS**

- R4.8.1 When a swimmer is unable to compete in a meet due to illness or injury, a full refund of entry fees will be granted on production of a medical certificate

#### **R5 AUCKLAND SWIMMERS INCENTIVE SCHEME**

- R 5.1** The Association may from time to time decide whether or not to allocate funds to the Auckland Swimmers' Incentive Scheme (ASIS).
- R5.2** The Board shall decide the amount, if any, of funds to be allocated to the ASIS at their first meeting, after the Association Annual General Meeting. Such amount may subsequently be varied by the Board should there be a significant change in the financial position of the Association.
- R5.3** The designated meetings to which the ASIS will apply are the NZ Summer (Long Course) Championships or its equivalent meet; NZ Open (Short Course) Championships; 5km Open Water Championships; NZ 25km Open Water Championships, or such other NZ Championship meets as the board shall determine from time to time.
- R5.4** Each year the Board shall determine the basis of allocation of any funds allocated to ASIS.
- R5.5** At the meetings of the Board immediately following the completion of the NZ Open Summer & Winter Championships or the equivalent championships, the Registrar will submit a schedule showing the name and club of the swimmers who have qualified for a payment from the ASIS. Alongside each swimmer's name is to be recorded the amount allocated to them in accordance with the funds referred to in R5.2 and in the ratio set out in R5.4.
- R5.6** Following approval by the Board of the schedule referred to in R5.5; the Administrator is to circulate a letter to each swimmer named on the schedule advising them of the amount they may claim under the ASIS. A copy of the letter is also to be mailed to the Secretary of the club represented by the swimmers.
- R5.7** Swimmers qualifying for a payment from the ASIS are to submit a written application to the Administrator setting out the costs incurred in respect of competing -
- (1) Overseas as a member of a New Zealand team
  - (2) Within New Zealand as a member of a New Zealand team
  - (3) Overseas as a member of a selected Auckland team
  - (4) In the Australian Open and/or Australian Age Group Championship, but not an Australian State Championship unless (1) or (3) above applies.
  - (5) The designated meeting to which the ASIS will apply are the NZ Winter Championships; NZ Open Summer Championships; \*NZ 5km Open Water Championships, NZ 25km Open Water Championships \*\*
  - (6) Any other meet determined from time to time by the Board
- Such costs must have been incurred no earlier than the date of the meet at which the swimmer qualified for the incentive payment  
ALSO the costs submitted must not already have been reimbursed from any other source e.g. SNZ or the swimmer's club.



- R5.8** The written application submitted by the swimmer is to be endorsed by the swimmer's club secretary.
- R5.9** Funds not claimed within two years of the letter circulated in accordance with R5.6 will be forfeited and become available for re allocation in respect of the year of forfeiture.
- R5.10** The ASIS allocation shall be made to a swimmer resident in the Auckland Swimming Association Region for at least 50 per cent up of the year under consideration, and a member of a club of the Auckland Swimming Association during the year under consideration

## **R6 AUCKLAND TEAMS**

### **R6.1 DEFINITION OF TEAM**

Swimmers being members of Clubs of the Association attending inter-region or, North Island or National competitions will be designated an Auckland Team. Swimmers may also be assembled for specified competitions and as such may also be designated an Auckland Team. Such teams will come under the authority of the Auckland Swimming Association while attending the venue.

### **R6.2 TEAM MANAGERS**

- R6.2.1** When teams attend a swim meet or are assembled as in the foregoing, the ASA Board will appoint a team manager on the basis of one manager per team and any further managers should the composition of the team so warrant.
- R6.2.2** Whenever it is deemed that a Manager or Managers are required the ASA Board may call for nominations from Clubs for persons to be appointed as Managers.
- R6.2.3** The ASA Board shall appoint the required number of team managers from the nominations. Where there are no nominations for the position of team Manager, the ASA Board may appoint any suitable person to that position.
- R6.2.4** The ASA Board may appoint further team Managers for any team, regardless of numbers, if, in the opinion of that Committee, the circumstances so warrant such further appointments.
- R6.2.5** The Team Manager or Managers will have the authority as delegated by the ASA Board to require members of the team to adhere to a Certificate of Behaviour as set out in Regulation R6.7.
- R6.2.6** The ASA Board may delegate the power of appointment of managers, either generally or in any specific instance, to the Chair or Deputy Chair

### **R6.3 REIMBURSEMENT OF MANAGERS**

- R6.3.1** Managers so appointed shall be reimbursed their travel expenses on the basis that it shall be not more than actual costs of fuel used for a motor vehicle if travelling to a venue north of and including the townships of Te Kuiti, Taupo, Rotorua and Whakatane.
- R6.3.2** When Managers are required to travel south of the line described in R6.3.1 they shall be reimbursed costs of travel not exceeding the standard economy return airfare to the venue.



- R6.3.3 Where the payment of travel (or accommodation as in R6.4.2) is made by the Manager or Managers, claims on such payments are to be supported by receipts, bearing a GST number, which must be submitted to the ASA Board before reimbursement is made.
- R6.3.4 Notwithstanding the provisions of Regulation R6.3.1 and R6.3.2 the ASA Board may at least three months prior to any team travelling within New Zealand decide that a fixed amount will be paid to any Manager or Managers appointed as an ex-gratia payment to assist with expenses.
- R6.3.5 Where payment is made in accordance with Regulation R6.3.4 no other claim shall be made on the Association for travel expenses under the provisions of Regulation R6.3.1 or R6.3.2.
- R6.3.6 Where a Manager is appointed under Regulation R6.4.2 the Manager or Managers will have all travel and accommodation expenses paid for by the Association.
- R6.4 MANAGERS RESPONSIBILITY**
- R6.4.1 Unless otherwise directed by the ASA Board Managers shall be responsible for the team only while at poolside, and are specifically excluded from any responsibility for members of the team whilst they are not attending the Pool.
- R6.4.2 Where a Manager or Managers are appointed to a team that has both travel and accommodation organised by the Association the Manager or Managers will travel with and stay with the team and as such Regulation R6.4.1 shall not apply.
- R6.5 HEALTH FORM**
- A form as designated from time to time by the ASA Board shall be completed by members of Auckland Teams travelling overseas or to National Championships detailing the health of the member. Such form shall be handed to the Manager of the team prior to departure. The contents of the form will be confidential to the Team Manager.
- R6.6 BIRTH CERTIFICATE**
- When requested team members will provide to the Team Manager or the Registrar a certificate or other acceptable proof as to Date of Birth. Such proof will be sighted and recorded and returned to the team member.
- R6.7 BEHAVIOUR CERTIFICATE**
- Prior to travelling team members will provide to the Team Manager a Certificate of Behaviour in the form prescribed from time to time by the ASA Board.
- R6.8 UNIFORM**
- Members of teams while at poolside shall wear an Auckland Uniform or uniform top as and when specified either generally or specifically by the ASA Board. At other times team members shall wear a Club Uniform not inconsistent with the requirements of the Meet Management



## **R7 ASSOCIATION RECORD TIMES**

### **R7.1 RECOGNITION**

- R7.1.1 All Auckland Records shall be recognised by the Association whether established within the Association area or outside it PROVIDED HOWEVER that in every case where such a record at a meeting other than a Meeting organised and run by the Association and where more than one record in the same event is claimed on the same date such record application shall include a certificate as to the time that the record was established from the Referee of the meet at which the record was set.
- R7.1.2 The Association shall consider applications for recognition of record performances only where such records have been established by swimmers eligible under Rule R2.01.3 either in scratch competition or in an individual race against time, decided in public and duly fixed and advertised in accordance with these regulations NZR8.3, NZR8.4, NZR8.5, NZR8.6 and NZR 8.8. The time shall be taken by Electronic Timing Equipment with at least two (2) time-keepers or three (3) time-keepers with watchers.
- R7.1.3 All Auckland Long Course records are recognised in metres only and shall be set in certified 50 metre or 55 yard pools.
- R7.1.4 All Auckland Short Course records are recognised in metres only and shall be set in certified 25 metre, 33 and one third metres and 36 and two third yard pools.
- R7.1.5 Application for recognition of an Auckland record will be checked by the Registrar and submitted for ratification by the ASA Board of the Association. Once ratified, the record will be recognised by the issue of a Certificate to the competitor or in the case of a Relay team, to all members of that team.
- R7.1.6 All Auckland records shall be recognised to one one-hundredth of a second.
- R7.1.7 Auckland relay records shall be recognised as Club Teams only and composite teams of two or more clubs can not claim an Auckland Record.

### **R7.2 APPLICATIONS**

- R7.2.1 Application must be made by the swimmer and/or their agent on the form prescribed from time to time by The ASA Board. That application together with supporting documentation shall be lodged with the Association Registrar not more than ten days after the event save when the performance was outside the Association area, in a recognised meeting, in which case the time lapse will be the discretion of the ASA Board providing all expediency has been observed.

### **R7.3 ATTEMPTS ON RECORDS**

- R7.3.1 A swimmer or his Club may apply to the Registrar for permission to make an individual attempt on a record other than at a recognised meet. This also applies to relay records where team members must all represent one club.
- R7.3.2 On approval of the Registrar the swimmer or his Club shall contact the Chair of the Technical Technology Group & advise the Registrar of the final details.
- R7.3.3 The swimmer/s or his Club shall be liable for any Pool charges incurred.



**R7.4 OFFICIALS**

R7.4.1 All officials for attempts on records in accordance with Regulation R7.3 shall be appointed or approved by the Technical Technology Chair and shall consist of a Referee, a Starter, three Timekeepers and a Chief Timekeeper. All shall hold the appropriate qualification of at least Association level. No person shall hold more than one position.

**R7.5 LISTS**

R7.5.1 The Registrar shall from time to time publish a list of all records as directed by the ASA Board.

R7.5.2 Notwithstanding Regulation R7.5.1, the Registrar shall supply to the Manager of all Auckland Teams an up to date list of all Records prior to the team departing Auckland.

R7.5.3 The Registrar shall make available to the Meet Director of the Auckland Championships and the Controller of any Association controlled meet an up to date list of all records.

**R7.6 DISTANCES / AGE GRADES**

R7.6.1 Auckland Long Course Records shall be recognised for the following events for both males and females in the open grade and age grades of 18yrs, 17yrs, 16yrs, 15yrs, 14yrs, 13yrs, 12yrs, 11yrs, 10yrs, 9yrs and under. Age as at the day of the performance:

Freestyle	50m., 100m., 200m., 400m., 800m., 1500m.
Backstroke	50m., 100m., 200m.
Breaststroke	50m., 100m., 200m.
Butterfly	50m., 100m., 200m.
Individual Medley	200m, 400m.

R7.6.2 Auckland Short Course Records shall be recognised for both males and females in open grade and age grades of 18yrs, 17yrs, 16yrs, 15yrs, 14yrs, 13yrs, 12yrs, 11yrs, 10yrs, 9yrs and under. Age as at the day of the performance.

In each of these grades the events are as listed for long course records as in Regulation R7.6.1. with the addition of 100m. Individual Medley in 25 metre pools only.

R7.6.3 \*Auckland Inter-club Relay records will be recognised for both males and females in open and age grades for the following events in long course pools only. (Refer to R2.15.9 for eligibility to "swim up.")

16 years and under	4 x 50m freestyle	4 x 50m medley
15 years and under	4 x 50m freestyle	4 x 50m medley
14 years and under	4 x 50m freestyle	4 x 50m medley

12 years and under	4 x 50m freestyle	4 x 50m medley
11 years and under	4 x 50m freestyle	4 x 50m medley
10 years and under	4 x 50m freestyle	4 x 50m medley
9 years and under	4 x 50m freestyle	4 x 50m medley



## **R8 TIME TRIALS**

- R8.1 The Club organising the Time Trial is required to give ten (ten) days notice to the Chair of the Competitive Swimming Group, the ASA Registrar, ASA Technical Technology Group Chair and other ASA clubs in the Association area.
- R8.2 The Club organising the Time Trial shall be liable for any Pool charges incurred and may charge a fee to cover those costs.
- R8.3 Clubs wishing to participate in the Time Trial are to advise the Host Club at least three (3) days prior, the number of swimmers taking part.

## **R9 OFFICIALS QUALIFICATIONS**

### **R9.1 RECOGNITION**

- R9.1.1 The following Technical qualifications shall be recognised by the Auckland Association. They are:

Referee,  
Starter,  
Recorder,  
Judge / Inspector of Turns  
Timekeeper and  
A.O.D Operator.

- R9.1.2 When a member of a Club within the Association area obtains a pass for any qualification under this Regulation he/she shall be issued by the Registrar with a credential card showing the level of qualification.

### **R9.2 REQUIREMENTS**

Before being examined at any level for qualification the applicant shall:

- R9.2.1 Prior to their credentials being validated and issued, successful Applicants must be registered
- R9.2.2 Satisfy the \*Association Examiner that he has had sufficient practical experience to warrant examination.
- R9.2.3 Apply to sit the examination on the form approved from time to time by the Technical/Technology Group of the Association.
- R9.2.4 If the examination is for Referee the applicant must also hold \*Association qualification in at least two of Starter, Judge or Timekeeper and an Auckland pass in the theory of the other.
- R9.2.5 Applicants for National qualification shall hold Association qualification at the level being sought and such application shall be submitted through the convenor of the Association Technical/Technology Group who shall ensure that such application conforms with any Swimming New Zealand ruling prior to submitting the application through the Association Administrator.
- R9.2.6 Applicants who have their applications submitted in accordance with R9.2.5 shall have their examination fee to Swimming New Zealand paid by the Association.

### **R9.3 EXAMINERS**

- R9.3.1 The Technical Technology Group shall appoint annually under the terms of Rule 7.06.3 examiners for each level of qualification.
- R9.3.2 The examiner for the level of Referee shall hold as qualification the level of National Referee prior to being appointed.
- R9.3.3 Examiners for other levels shall hold the level of Auckland Referee as well as the National qualification for the level he is to examine.

## **R10 ZONES**

### **R10.1 CONSTITUTION OF ZONES**

- R10.1.1 There shall be three Zones of the Association Region, namely CENTRAL, NORTHERN and WAITAKERE, such Zones generally conforming to the geographic location of the Clubs.
- R10.1.2 The Central Zone shall consist of the following Clubs; Mt. Eden, Onehunga, Roskill, Mt Wellington, Parnell, Total Aquatics, Metro and Central City.
- R10.1.3 The Northern Zone shall consist of the following Clubs; Devonport, North Shore, Northcote, Kowhai and Coast.
- R10.1.4 The Waitakere Zone shall consist of the following Clubs; Helensville, RNZAF Base, West Auckland Aquatics, Waitakere City, Kelston Aquatics and Waterhole.
- R10.1.5 Additional Clubs may be added to a Zone from time to time by the ASA Board and confirmed by alteration of this regulation in accordance with the rules of the Association.
- R10.1.6 Clubs may apply to the ASA Board to operate with and be part of any other Zone.

### **R10.2 MANAGEMENT**

- R10.2.1 Each Club within a Zone shall have the right to nominate two delegates to a Zone Committee and that committee shall appoint either from those delegates or otherwise as that committee shall determine a Chairman, Deputy Chairman, Secretary and Treasurer or Secretary/Treasurer.
- R10.2.2 Where the Chairman of the Zone is appointed from one of the delegates to the Committee, that person shall no longer hold a deliberative vote and the Club that that delegate represented will be entitled to appoint a replacement delegate.

## **R11 CLUB LEAGUE**

- R11.1 All Clubs within the Association Region shall be entitled to have teams swim in CLUB LEAGUE.
- R11.2 Club league shall be organised by the Events Management Group so that all Clubs shall have the opportunity to contest a league series at least twice in any twelve months.
- R11.3 The Competitive Swimming Group shall have the authority to draw up rules for the government and running of "Club League" not inconsistent with these Regulations or the Rules of the Association or SNZ Inc.
- R11.4 For all League Meets the provisions of R4.1.6 (b) and (c) shall apply.

## **R12 TROPHIES**

All Trophies except where otherwise stated are limited to members of Clubs within the Association.

### **R12.1 LOU RICHARDSON MEMORIAL CUP**

Presented by the Waitemata Amateur Swimming Club to perpetuate the memory of the late Lou RICHARDSON. First contested in 1955. Awarded to the male swimmer gaining the most points in the Auckland Open Championships. Points shall be allotted as follows:

1st	5 points
2nd	3 points
3rd	1 point

### **R12.2 TED HARDING TROPHY**

Presented by the Onehunga Amateur Swimming and Life Saving Club in recognition of the services rendered to the sport by Mr. R.E. HARDING. First contested in 1965. Awarded to the lady swimmer gaining the most points in the Auckland Open Championships. Points shall be allotted as follows:

1st	5 points
2nd	3 points
3rd	1 point

### **R12.3 BRIDSON CUP**

Presented by Mrs. W.M. BRIDSON for competition between Auckland Clubs. First contested in 1946/47. Awarded to the Club gaining the most points in Open Events at the Auckland Swimming and Diving Championships. Points shall be allotted as follows:

1st	5 points
2nd	3 points
3rd	1 point

### **R12.4 AUNTY JOHNSON TROPHY**

Presented by the Parnell Club in memory of a long serving team Chaperone. First contested in 1939/40. Awarded to the Club gaining the most points in the Age Group events up to and including <sup>2</sup>16 year olds, of the Auckland Swimming and Diving Championships. Points shall be allotted as follows:

1st	5 points
2nd	3 points
3rd	1 point

### **R12.5 PREMIER CLUB BANNER**

First contested in 1961/62. Awarded to the Club gaining the most points at the Auckland Inter-Club Relay Championships. Points shall be allotted as follows:

1st	5 points
2nd	3 points
3rd	1 point

Description: White Satin Banner, Silver Trim embroidered in Pakistan by male operators. Blue insignia of the NEW ZEALAND AMATEUR SWIMMING ASSOCIATION. Other lettering in red. Cased in Timber, bronze and plate. Remains the property of the Auckland Swimming Association



Donors: Auckland Glass Company Ltd. through Mr. Pascoe REDWOOD and Berlei (NZ) Ltd through Mr. F. DUNN.

Lost in the mid 1980's and replaced in 1989 by TISCO Ltd with a banner incorporating the logo of the Tisco Company and the current logo of the Auckland Swimming Association.

**R12.6 HALLYBURTON JOHNSON SHIELD**

R12.6.1 Presented for competition among Auckland Clubs. First contested in 1945/46 for points gained in inter-club meetings.

R12.6.2 Inter-club meetings, as such, ceased with the inception of Zone competition in 1976.

R12.6.3 From 1976 awarded to the Club gaining the highest aggregate points in the Bridson Cup, Aunty Johnson Trophy and the Premier Club Banner.

1st 5 points  
2nd 3 points  
3rd 1 point

R12.6.4 From 1992, the points scored in each of the above trophies are to be converted to a percentage of the points scored for each trophy. The highest aggregate of the resulting percentages will determine the winner.

R12.6.5 From 1996, awarded to the Club gaining the highest aggregate points in every final (top eight in events declared on times e.g. 400m, 800m and 1500m etc) in both age group and open events, and including visitors.  
Should the shield be won by a visiting club, it is to remain in Auckland.  
Points for placings in finals:  
(a) Open events - 18, 16, 15, 14, 13, 12, 11, 10  
(b) Age Group events - 9, 7, 6, 5, 4, 3, 2, 1

**R12.7 DALTON TROPHIES**

R12.7.1 Two Trophies presented by Mr. W.L. (Bill) DALTON (Patron) in 1970. One each to be awarded to the Auckland Boy and Girl whose performances in the Auckland Age Group Championships show the most excellence and versatility taking into account the most proportions of wins and placings within an age group and the quality of the performances as related to current Auckland Records within that grade.

R12.7.2 The trophy is restricted to:  
1. Grades - 15 years and under.  
2. Events - 50m, 100m, 200m and 400m but not 800m and 1500m.  
3. Calculations to be made on year grades from within mixed grades, for both 'wins' and records.

R12.7.3 *First calculation - VERSATILITY category*  
Excluding visitors, to find the top Auckland swimmers in each of the seven year grades: 15 yrs, 14 yrs, 13 yrs, 12 yrs, 11 yrs, 10 yrs, 9/u, for the fifteen events available to each - 50m, 100m, 200m, 400m in each stroke plus medley events, but excluding the 800m and 1500m freestyle.

Versatility points are to be allocated on at 150, 90, 30 basis for the top three competitors in each event.

The maximum score of 2050 points is available for a swimmer who wins all events as listed above, within his/her grade.

When an event is swum as a mixed grade, e.g. 14 years and under, this is to be broken into yearly grades, with 9 years and under as the youngest grade.

Heat times to be used where a swimmer did not qualify for a final, but times swum in finals take precedence over heat times.

#### R12.7.4 *Second calculation - EXCELLENCE category.*

The top versatility points scorers in each grade, seven boys and seven girls, are then eligible for excellence points.

Only the best performance of each swimmer, determined by comparison with the current Auckland Record within that grade, is to receive extra points as follows:

This scale will give a zero score for missing records with times outside the limits, similarly a ceiling of plus 1000 points for breaking a record by up to the above limits.

Examples:

Breaking a 400m record by 10s or more earns 2000 pts

By being 0.01s outside a 400m record earns 999 pts.

R12.7.5 The VERSATILITY score and the EXCELLENCE score are added to determine the boy and girl winners of the trophies.

#### R12.8 **PETTIT CUP**

Presented by Dr. Harold T. PETTIT in 1937 to encourage distance swimming in Auckland. Awarded to the swimmer gaining the most points in Handicap Harbour Races. Points shall be allotted as follows:

1st	5 points
2nd	3 points
3rd	2 points

and each starter 1 point and an additional 1 point for the swimmer recording the fastest time.

#### R12.9 **D. McL. WALLACE LTD CUP**

Presented by D. McL. WALLACE LTD. as a trophy for the handicap section of the Auckland Long Distance Championship. First contested in 1946. Restricted to Auckland Registered swimmers only.



**R12.10 PARNELL JUBILEE CUP**

Presented by the Parnell Club to commemorate their 50th year (1966). Awarded to the winner of the Auckland Men's 100 metre Freestyle Championship.

**R12.11 PONDER SHIELD**

Presented in memory of Miss Jean PONDER. Awarded to the winner of the Auckland Ladies 100 metre backstroke Championship. First contested in 1957.

**R12.12 BRIAN PIKE MEMORIAL CUP**

Presented in memory of Brian PIKE by the North Shore Club. Awarded to the first junior under 16 years of age in the final of the 200 metre men's Auckland Backstroke Championship. If no junior contests the final then awarded to the fastest winner of the boys 200 metres back stroke championship, 15 years or younger age group championship. First contested in 1964.

**R12.13 PRESIDENTS CUP**

Presented by Mr. N.S. BATCHELOR in 1969, to be awarded to the winner of the girl's 100-metre freestyle sprint championship in the youngest grade recognised at the championships.

**R12.14 NEWMARKET CENTENNIAL CUP**

Presented by the NEWMARKET BOROUGH COUNCIL in 1969 to mark the Centenary of the Borough. To be awarded to the winner of the Ladies 100 metre freestyle championship.

**R12.15 AUCKLAND CENTENNIAL CUPS (2)**

R12.15.1 Awarded by the Auckland City Council to commemorate the City's Centenary (1971).

R12.15.2 One awarded to the winner of the men's 100 metre Backstroke at the Auckland Swimming Championships.

R12.15.3 One awarded to the winner of the women's 100 metre Breaststroke at the Auckland Swimming Championships.

**R12.16 MORRIS TROPHY**

Presented by the MORRIS family. First contested at the Auckland Championships in 1982/83. Awarded to the winner of the Ladies 200 metre Breaststroke.

**R12.17 MOUNT EDEN TROPHY**

Presented by the Mount Eden Club. First contested at the 1983/84 Auckland Championships. Awarded to the winner of the men's 200 metre Breaststroke.

**R12.18 VICE-PRESIDENT'S TROPHY**

R12.18.1 Donated by Mr. D.C.O. (Dan) BENNETT, Vice President, in January 1985. To be awarded annually for junior girl's freestyle as follows:

R12.18.2 Eligibility restricted to girls aged 12, 13, 14 and 15 as at the age date for the Auckland Age Group Championships.



R12.18.3 To be awarded after consideration of age group girls performances for the 100 metre Freestyle, 200 metre Freestyle 400 metre Freestyle on a point's basis.

First	12 points	Fourth	6 points
Second	10 points	Fifth	4 points
Third	8 points	Sixth	2 points

R12.18.4 In the event of a tie, the trophy winner is to be decided in favour of the tied swimmer who has bettered by the widest percentage margin or come nearest to the New Zealand Age Group Long Course freestyle record corresponding to her current yearly grade.

R12.18.5 Open performances by age group swimmers are NOT to be included in the calculation of the points.

The points for 12yr olds will be calculated from the results of the 12 yr grade only, when both a 12 yr grade and a 13/u grade are held

**R12.19 LAWRIE REED MEMORIAL TROPHY**

Awarded by an anonymous donor in 1989 in memory of Mr. L.R. (Lawrie) REED, past Chairman and President of the Auckland Centre. To be awarded to the winner of the 13/14 year girls 200 metre Breaststroke at the Auckland Championships.

**R12.20 DE NOUVELLE CALEDONIE TROPHIE**

Presented by the New Caledonian team to commemorate 21 years of competition at the Auckland Championships. Awarded for the most outstanding performance by a visitor at the Auckland Championships.  
To be awarded by the ASA Selectors' Panel.

**R12.21 CHAMPION OF CHAMPIONS TROPHY**

Presented by Norma Williams, Life Member in 1986. To recognise excellence of performance. To be awarded each year to the Auckland Swimmer who, in open or age group events at the Auckland Championships registers a time closest to world standards.

The measure of performance to be calculated on a percentage basis of the current December 31st world rankings of 25th placing OR current NZ National Squad Standard.

NOTE: As at 1986 the New Zealand International Squad standards are relative to the World 25th rankings and so provide a simple measure for the leading candidates.

**R12.22 BATTY CUP**

Presented by W. BATTY for an interclub dual relay and first contested in 1925 and contested through to 1967. In 1986 it was reintroduced to be contested as an event at the Auckland Championships.

DUAL RELAY:

One man and one woman from the finalists in the open 50 metres freestyle championship event to each swim 50 metres freestyle in a dual relay. There shall be a draw for partners and lanes.

If the trophy is won by visiting swimmers, it is to remain in Auckland.

**R12.23 LOCKHART FAMILY TROPHY**

R12.23.1 Presented by Mr. Simon LOCKHART in December 1991 "in appreciation of the tremendous support and assistance that has been given by the Auckland Swimming Association to his children over the years," and to encourage breaststroke swimming.

R12.23.2 To be awarded to the male individual under the age of 16 years who records the fastest 100-metre Breaststroke time at the Auckland Championships.

**R12.24 WAITAKERE LICENSING TRUST TROPHY**

Presented by the Trust in 1993 for competition at the Auckland Winter Championships.

To be awarded an Auckland affiliated club swimmer registering the best performance of the meet in the opinion of a panel consisting of three coaches (including one from outside the Auckland Swimming Association) and one Auckland Swimming Association selector.

**R12.25 BRUCE WHINERAY TROPHY**

Presented by the Whineray family in 1981, in honour of their father Mr. Bruce Whineray who was Auckland President for eight years from 1953, as well as being Chairman for six of those years.

To be contested every six months at Autumn Dolphin League and Spring Dolphin League.

To be awarded to the most consistent team as decided by the League Organising Committee.

**R12.26 ARTIE SHAW TROPHY**

Inscribed (in part) "Re-union Bureau FINA Uruguay 1987". Presented by Mr. D.L.(Artie) Shaw, FINA Vice-President, in 1993 for competition at the Whineray Meeting each year, between visiting teams from Counties and Northland Centres and Auckland Zone Representatives.

To be contested every six months at Autumn Centre League and Spring Centre League.

To be awarded to the most consistent team as decided by the League Organising Committee.

**R 12.27 ROSS ANDERSON MEMORIAL TROPHY**

Presented in 1997 by the West Auckland Aquatics Swimming Club in memory of Ross Anderson, Coach of the Club and a Coach of national representative teams for many years.

To be awarded annually to the winner of the men's 400m medley at the Auckland Summer Championships.

**R 12.28 MERVYN RAYMOND MEMORIAL TROPHY**

Presented in 1998 by the Raymond family in memory of Mervyn Raymond, Life Member of the Auckland Swimming Association.

To be awarded annually to the winner of the men's 200m backstroke at the Auckland Summer Championships.



**R12.29 AQUA SHOP TROPHY**

Presented in 2004 by Mr Chris Lazaridis. To be awarded annually to the first Aucklanders in the Men's Open 100m Butterfly at the Auckland Summer Championships.

**R12.30 Norma Williams' Family 2006 Centennial Trophy**

To be awarded to the first member of an ASA Club in the final of the Men's Open 50 m Freestyle event at the ASA Summer Championships.

**R12.31 Norma Williams' Family 2006 Centennial Trophy**

To be awarded to the first member of an ASA Club in the final of the Women's Open 50 m Freestyle event at the ASA Summer Championships.

**R13 AWARDS**

**R13.1 SHANAHAN AWARD**

As from the 1975/6 season, a plaque is to be presented to those competitors who have won ten Auckland Open Swimming Titles. Championships won prior to that date are not eligible, and the Award may be claimed only once by any one competitor.

**R13.2 TED HARDING MEMORIAL SWIMMER OF THE YEAR**

R13.2.1 The award shall be presented to a member of a club of the Association during the year under consideration, who in the opinion of the ASA Selectors achieved the most meritorious performance. The year shall be defined as January 1st to December 31<sup>st</sup>

R13.2.2 It is also possible for the recipient of this award to receive the EVA TILSLEY TROPHY in any year.

**R13.3 EVA TILSLEY TROPHY**

R 13.3.1 From a bequest by Life Member Eva Tilsley this annual award shall recognise, from 1999, the most meritorious performance of a swimmer 18 years and under in the calendar year under consideration.

R13.3.2 The age date shall be determined by the age of the swimmer on the day of the performance during the period January 1st to December 31st.  
The swimmer must have represented an Auckland club for the full year.  
The Auckland selection panel shall determine the winner from performances within New Zealand as well as overseas where applicable.

R13.3.3 The winning of this Trophy does not preclude the winner from being considered for the Ted Harding Memorial Trophy in the same year.



## **R14 PENALTIES**

### **R14.1 PENALTIES ON CLUBS**

Unless otherwise specified in the Rules or Regulations of the Association any monetary penalty imposed on a Club for a breach of the Rules of the Association or these Regulations may not exceed the sum of One Thousand Dollars. (\$1,000.00)

### **R14.2 PENALTIES ON CLUB MEMBERS**

Unless otherwise specified in the Rules or Regulations of the Association any monetary penalty imposed on a Club member for a breach of the Rules of the Association or these Regulations may not exceed the sum of Two hundred and fifty dollars. (\$250.00)

### **R14.3 SAVINGS**

Nothing in this Regulation shall preclude the Association imposing any other penalty it is empowered so to do under the Rules of the Association or these Regulations.
