# Executive Officer's Report:

#### Active Schools

### Swimming New Zealand Remit:

Proposed by Auckland that the 1500m female and 800m male be reintroduced into the national competitive calendar. Rationale, NZ Records and Squad qualifying times are within these two events. Also, these events are still on the International calendar (e.g. World Long Course Champs). Swimming New Zealand need to give swimmers a chance to swim them.
