



of **Board Meeting** held on Thursday 20 November, 2008 at 7.30pm at Sports House, Harbour Sport, Stadium Drive, Albany

Welcome: Andy Brown welcomed David Jack to the first part of the meeting.

Register of Interests:

Suzanne Speer registered her conflict with regard to General Business - United Swim Club and Kings School.

Presentation by David Jack:

David presented SNZ's Updated Strategic Plan and the direction SNZ were taking. There was good discussion around the Strategic Plan in relation to Auckland Swimming's draft Strategic Plan. David spoke about how SNZ got through the process and what they had learned in going through the process. The purpose of SNZ is more focused on specific items. A couple of concerns was that with the credit crisis at present, is SNZ sustainable and secondly, there is not enough of a profile as SNZ requires.

1. Matters arising from previous Minutes:

<u>Incentive Awards</u>: Dominic discussed the drafted policy with regard to the Swimmers' Incentive Scheme and the Swimmers' Incentive Awards. This lead to good discussion with regard to swimmers being available to take part in the Auckland relay teams and it was agreed that the Policy required some amendments. Philippa to organize the process from management point of view.

Points noted:

Swimmers need to be a party to their withdrawal and understand the consequences. A swimmer entered into an event at any competition will be available to participate in any relay.

Auckland relay teams will be published at a reasonable time before an event. If a swimmer is unavailable, a relay withdrawal form must be filled out at a reasonable time before the event. In extenuating circumstances the Auckland Team Manager must be informed as soon as possible if a swimmer cannot partake in a relay. This will preferably occur before the beginning of session one.

Moved by Dominic Toomey that the following amendments be carried:

- 1. R5.10 be replaced with 13.4.3.
- 2. R13.4.4 be included, to read:

"The Board will have the sole discretion in determining whether or not to make an award under this regulation".

3. R5.4 A new paragraph be inserted, to read:

"The Board will foster an environment where swimmers are prepared to represent their Association in return for access to the Incentive Scheme".

<u>Takapuna Grammar</u>: Andy advised that he had met with Simon Lam (Principal) and registered Auckland Swimming's interest in the proposed aquatic centre.

<u>Media Contract</u>: Philippa advised that a letter was forwarded to David Worsley acknowledging the work that he had done for Swimming Auckland and advising that Swimming Auckland no longer required his services.
